The Proposal:

Chemtrade's facility in North Vancouver produces up to 70 per cent of the liquid chlorine used to treat drinking water in BC and Alberta. This equates to 40 per cent of available liquid chlorine in Canada.

Chemtrade has proposed several major capital improvements aimed at increasing safety and reducing risk for the community. In order to move forward with these projects and to have the production of liquid chlorine listed as an allowable activity on its land, Chemtrade needs the District of North Vancouver's approval to amend its prohibited uses regulations in relation to this property. All other zoning regulations related to this property will remain unchanged.
