Other happenings in 2025:

At the end of September, the annual cleanup at Blueridge Creek was held on World Rivers Day. It is another wonderful tradition started by a local resident years ago. It's always great to see kids involved in such activities.

Our association has again shown leadership by firing off a letter signed by all 12 directors on behalf of our community to our NDP MLA Susie Chant, and the DNV council, demanding a public inquiry into the massive budget over-run of the North Vancouver Wastewater Treatment Plant.

We also took on an initiative, previously unseen on the North Shore, to host a Town Hall meeting Oct. 15. We invited our Liberal MP Terry Beech, Ms. Chant, and Mayor Mike Little to field questions from residents. As we do at our election-time All Candidates Meetings, we joined forces with our friends at the Deep Cove Community Association and the Deep Cove Community Association.

Our Blueridge Spirit Award and our scholarship will continue into 2026, and we are also pleased to share some other good news. It appears that our very popular Dîner en Bleu, a feast-on-the-street event, is making a comeback! Finally, we are also trying to promote "Neighbours Helping Neighbours"—ways of helping each other out. ### Trails closed while work continues on former Blair Rifle Range

hile it's been many decades since the former military munitions site has been active, Canadian military officials say they will continue searching for unexploded explosive ordnance (UXO) from the site east of Blueridge and Seymour Heights.

"To ensure continued safe community use of the site, UXO contractors will continue clearing the munitions from the forested areas until March 31, 2026, with a brief pause over the Christmas holiday and into January, a Department of National Defence (DND) spokesperson says in a recent news release.

"During this time, the contractor will be clearing additional areas in the northern section of the site, and for safety reasons, select trails will be closed on an intermittent and rotating basis while work is underway."

For more details on trail closures, please look at the Blueridge website (www.blueridgeca.org). Open trails continue to be safe for the community to use for walking, jogging or biking.

The website map delineates (in light green) the extent of the UXO clearing since the DND returned to the site in 2023, the spokesman said. "Our priority remains the safety and security of the community, and we are committed to keeping you informed."

Meanwhile, the spokesman added, that if residents encounter something that looks like a UXO, they should:

- Not touch it
- Turn around and leave the area the same way you came in
- Call 911 or local RCMP If residents have any questions about the clearance work, please visit the DND website or email the DND at UXOCanada@forces.g.ca.



### Where Do We Put 20,000 New Living Units by 2041?

rovincial legislation (Bill 44) sets a target for housing growth in the District of North Vancouver. The District is required by this legislation to have zoned capacity for approximately 20,000 additional living units by 2041. This is approximately twice the pace of current development in the District. If we fail to create this zoned capacity, we face the prospect of the province intervening to accomplish the goals of the legislation.

It is, to many of us, problematic that the province is setting specific goals of housing growth without putting into place equally detailed plans for expanding infrastructure. Where are the plans to upgrade our transportation and other infrastructure to accommodate this increased population? When will we see a SkyTrain to the North Shore? When will our health-care capacity be developed to meet this increased demand? These are practical questions that, in the view of many, must be answered before we can seriously contemplate doubling our rate of housing development. There are also serious questions to be answered regarding the fiscal impacts of all this growth. Will this plan to add an extra 20,000 living units within 16 years put a strain on District taxpayers?

However, Bill 44 requires us to rezone in advance in a manner that accommodates these new units. The legislation is mandatory. What remains for Council to decide is how and where to direct this mandated population growth.



At the October 20, 2025, Council meeting, we passed the first reading on an Official Community Plan Amendment to guide this future growth. The majority of Council (Mayor Little, Counsellors Muri, Forbes and Mah) voted for a plan to incorporate this extra growth within our existing growth plans. A minority (myself and Councillors

Pope and Back) voted in favour of an alternative plan that would have targeted this extra growth

into expanded town centres and growth corridors. As stated in this staff report: "[This alternative plan] on balance provides greater opportunities for further diversity of housing types and more housing in centres and along corridors where there is greater access to transit, daily needs and amenities."

I will continue to speak out against the housing growth mandates of Bill 44. I believe, with all due respect to the provincial government, that Bill 44 is poor public policy and that to mandate housing growth without a plan for infrastructure investment is not in the best interests of the District. However, if we are required to zone to add housing units at this pace, I believe that we are better off adding this zoned capacity in expanded town centres and growth corridors and protecting our single-family zones.

The OCP amendments will proceed to a public hearing. Come out and have your say. Tell us where you would like to place 20,000 additional housing units over the next 16 years. At the same time, please communicate with your provincial representatives (your members of the BC Legislature) and tell them how you feel about our community being mandated to grow in population without a corresponding plan for investments in critical infrastructure.

## Range of thorny topics raised at town hall meeting

### Opinion: Is the Board of Metro Vancouver Worth the Cost? A Call to Action.

efore the debacle of the North Shore Wastewater Treatment Plant, I took it for granted that the Board was on the side of the three million citizens of Metro Vancouver. I didn't pay much attention to what was happening until the Board gave its members huge pay increases while at the same time announcing the original cost of the Treatment Plant, estimated at the time at \$700 million, was going to cost \$3.9 billion. Without providing any substantive explanation. And refusing to allow any kind of audit. And taking steps to ensure that no audit, at least an independent one, would never take place.

Of course, the Board runs its own show. No accountability to those three million citizens who pay for their projects, their salaries and perks, including travel to faraway lands and expensive hotels and meals. Not even any apparent embarrassment for mishandling the construction of the Treatment Plant. And there is more to come.

The current estimate does not include the remediation of the current treatment plant under the Lions Gate Bridge. It does not include costs of litigation leveled against Metro by the engineering firm entrusted by them to carry out the project. True, there may be some offsetting income from the countersuit that Metro has levelled against the same engineering firm. Is this all that we can expect from Metro in terms of looking after our interests? Or is all this posturing an expensive tactic to avoid letting us citizens, the people paying the bills, know the details of what went wrong and who is responsible?

The court cases will not come to trial until 2027. Note that civic elections will be over and done with by then. No examinations for discovery (a step in law suits where the parties ask each other questions) have started. What's your bet that we will ever find out who bears the blame for this fiasco? Or will the cases be settled and the results hidden behind non-disclosure agreements? Given what has transpired so far, my bet is that we will never know. Unless...

The Provincial Government has both the power AND

the responsibility to invoke Section 764 of the Local Government Act to order a public inquiry into this horrifying situation. That is the ONLY avenue that can ensure that facts are established, procedural processes are amended to potentially avoid recurrences of huge projects going off the rails, and any negligence brought to light.

Why does the Provincial Government not do its job and invoke Section 764? Are they hiding something? Protecting someone? What level of TRUST do you have in our democracy and its ability to withstand mismanagement and/or deliberate malfeasance? On a scale of one to ten, mine has dropped from eight to one. Yes, I'm angry. That's what disillusionment does.

Your Association has done its job by writing to the North Vancouver District Council and our local MLA. You can find the letter on our website. Now it's your turn to let our government know what you think. The more that citizens push, the more likely it is that elected officials will do the job we elected them to do.
